

Meet with Confidence Points & Perks Offer – Terms & Conditions

Meet with Confidence Points & Perks Offer (the “Offer”) available at participating IHG® hotels in the U.S., Canada, Latin America & Caribbean, Mexico, Europe, the Middle East, India, Africa, Southeast Asia, Korea, Australia, New Zealand, South Pacific unless prohibited by law. Hotels that do not participate in IHG Business Rewards, and do not participate in this Offer, include the Venetian | Palazzo, Six Senses properties, and non-IHG branded hotels such as Mr. and Mrs. Smith properties. You must confirm that the hotel you are contracting with is a participating hotel for purposes of the Offer. Offer applies only to group bookings of at least 10 rooms on peak and up to 50 guestrooms on peak. Offer allows for no cancellation fees if group event is cancelled at least 14 days prior to contract start date (scheduled arrival date), and no rooms revenue attrition fees when group block is adjusted at least 14 days prior to contract start date (scheduled arrival date). The earning structure is notwithstanding the limits set forth in the Business Rewards terms.

Complimentary Meeting Room is for a maximum of 8 hours and maximum of 50 people. Complimentary Meeting Room does not qualify for any IHG Business Rewards points. Complimentary space is subject to 10 or more consumed guest rooms on peak and to meeting space availability. Food and beverage minimums may apply.
